## Dying Communism

State Program of Economic Research

patchwork of research projects in the hands of liberal technocrats organized loosely across institutions; themes as structural problems of socialist economy; role of science, education, sport, culture, health care and social welfare in society; development and utilization of human potential; steering of economy and society *etc*.

1980s

### 1989 and after

 Program Committee of the Civic Forum and other programmatic civic initiatives

Opportunity window: deep motivation to improve human conditions. Many ideas and inspirations from within Czech society and from abroad; missing skills and links to Western science, non-existent training capacities
